IMPORTANT NOTICE TO ALL BUSINESSWORKS USERS USING BW 2011 (or older):

Effective January 1, 2022, the Illinois Department of Revenue (IDOR) income tax withholding rate is unchanged and remains 4.95%, but the minimum wage increases to \$12.00/hour. Also the Illinois Department of Employment Security (IDES) states the taxable wage limitation used to calculate state unemployment insurance (SUI) is unchanged and remains \$12,960.00. IDES increased the contribution rates for 2022, and range from .725% to 7.625%. To accommodate these changes, you must make some adjustments to your Illinois Allowances Limits and Rates, and may need to modify your Illinois SUI Contribution Rate in BusinessWorks **before** processing your **first** payroll for 2022.

<u>Effective January 1, 2022</u>, the Internal Revenue Service has issued new tax tables and other wage withholding allowances, limits and rates. To accommodate these changes, you must make some adjustments to your BusinessWorks payroll tax tables <u>before processing your first payroll for 2022</u>.

<u>Effective January 1, 2020 (and after)</u>, new employees must submit the revised 2020 Form W-4. Current employees do not need to submit a new form unless the need to change their withholdings. Please refer to the **"2020 Form W-4 Overview"** and **"How to use 2020 Form W-4 for BusinessWorks v2011 and older"** documents in the BusinessWorks page on FLIsupport.com.


Overview

Effective January 1, 2022, the Illinois Department of Revenue (IDOR) income tax withholding rate is unchanged and remains 4.95%, but the minimum wage increases to \$12.00/hour. Also the Illinois Department of Employment Security (IDES) states the taxable wage limitation used to calculate state unemployment insurance (SUI) is unchanged and remains \$12,960.00. IDES increased the contribution rates for 2022, and range from .725% to 7.625%. Because unemployment rates vary from company to company, BusinessWorks will not inherently recognize the correct rate, meaning this adjustment must be manually recorded in BusinessWorks. This document provides step-by-step instructions to be performed **AFTER processing your last payroll for 2021, and BEFORE processing your first payroll for 2022**.

<u>Multiple Company Considerations</u>: Complete these State instructions in every company from which you perform payroll processing.

1) In the Payroll Module, go to Taxes > Maintain Tax Tables

3) Confirm the SUI Limit remains 12960.00. NOTE: The SUI Rate defined in this screen represents a "default" rate when you create new companies, and <u>is not</u> used to calculate your SUI liability. The rate used to calculate your SUI liability is maintained in the Activate States screen. You may change the SUI Rate in this screen to match your 2022 contribution rate, but it is an inconsequential change.



This is an informational message only; simply click OK to continue, and then close the Maintain Tax Tables screen.

- 3) Change the SUI Rate to the 2022 contribution rate provided by IDES for the company you are currently logged into*. If you have not received a 2022 contribution rate for this company, you must contact IDES to obtain the correct rate. Since BusinessWorks calculates SUI liability with each payroll, it is very important you enter the correct rate <u>AFTER processing your last payroll for 2021, and</u> <u>BEFORE processing your first payroll for 2022</u>. If you process 2022 payroll prior to setting this rate, you will be forced to expend manual effort to adjust SUI liabilities later. (Hint: If you have not previously entered your State Tax ID, you may be required to do so before establishing your SUI Rate)
- 4) Click Save, and then close the Activate States screen.
- 5) Repeat steps 1 4 for each company in which you perform payroll processing. You do not need to repeat this in companies where payroll is not used.

* - <u>NOTE</u>: Your SUI contribution rate may vary depending on the total wages paid. If you have a contribution rate when total wages are less than \$50,000, and a different rate when total wages are more than \$50,000, use the rate that corresponds to what you anticipate your total wages will be for all employees for the first quarter of 2022. If your total wages change for subsequent quarters in 2022 you must change your SUI rate as close as possible to the beginning of that quarter.

2022 Federal Wage Withholding (based on 2022 IRS Publication 15 (Circular E) Employer's Tax Guide)

Overview

Effective January 1, 2022, the Internal Revenue Service (IRS) is changing the wage withholding tables and other allowances, limits, and rates used to calculate employee withholding amounts. If you do not currently subscribe to BusinessWorks Support, you must manually update Federal tax tables in BusinessWorks. This document provides step-by-step instructions to be performed <u>AFTER processing your LAST payroll for</u> 2021, and BEFORE processing the FIRST payroll for 2022.

Multiple Company Considerations: Changes made to your federal tax tables will be reflected in all companies – you will perform the following Federal steps only once, regardless of the number of companies you use to process payroll.

Make sure the FICA rate for both Company and Employee = 6.200. The FICA Limit, OASDI portion is 147,000.00. Set the Withholding Allowance to 4300.00. Make sure the FUTA rate = 0.600. Change the Minimum Wage to 12.00 (Illinois). All other values may remain the same (or as shown in the image below).

<u>NOTE</u> - In addition to withholding Medicare tax at 1.45%, you must withhold a 0.9% Additional Medicare Tax from wages you pay to an employee in excess of \$200,000 in a calendar year. You are required to begin withholding Additional Medicare Tax in the pay period in which you pay wages in excess of \$200,000 to an employee and continue to withhold it each pay period until the end of the calendar year. Additional Medicare Tax is only imposed on the employee. There is no employer share of Additional Medicare Tax. All wages that are subject to Medicare tax are subject to Additional Medicare Tax withholding if paid in excess of the \$200,000 withholding threshold. Contact FLI if you have any employees whose gross wages exceed \$200,000.

- 4) After changing the Limits listed in Step 3, click OK at the bottom of the screen. This will return you to the Maintain Tax Tables screen.
- 5) Click Save in the toolbar at the bottom of the Maintain Tax Tables screen (the button with the green diskette image).
- 6) Click the Table 1 (Single) button

7) In the Single Tax Table, select the first line in the table, and then click the Delete button. Repeat until all lines are removed except the last line (system will not allow you to delete the last line. Use the chart below to enter each line starting from the first line (0.00 - 3950.00 - 0.00 - 0.000). After entering each line as listed click Accept, then repeat this step until all lines are entered. Click on the last line and click the Edit button on the right side of the window. Enter the amounts shown below for the last line and click Accept. After entering the last line, if the Base Amount does not show the amount listed below (157804.25), click the Recalculate Bases button at the top and it should correct it. Click OK when finished.

Click on the last line and click the Edit button on the right side of the window. Enter the amounts shown below for the last line and click Accept. After entering the last line, if the Base Amount does not show the amount listed below (168993.50), click the Recalculate Bases button at the top and it should correct it. Click OK when finished.

After completing the steps listed above, continue processing your 2022 payroll as you normally would. BusinessWorks will calculate withholdings based on the tax information you entered.

****Special Considerations for 2022****

Form W-4 for 2020 and beyond is very different than prior versions. New hires after January 1, 2022 must use this new form. Employees hired prior to January 1, 2022 don't need to fill out the new form unless they need to update their withholdings. Please refer to the **"2020 Form W-4 Overview"** and **"How to use 2020 Form W-4 for BusinessWorks v2011 and older"** documents in the BusinessWorks page on FLIsupport.com.

Additional changes may be required due to Acts of Congress that become law after publication of this document. Payroll tax law changes could result in a requirement to purchase software upgrades to remain compliant. Additional information will be provided upon enactment of any additional payroll tax law changes.

You may be required to list Employer Provided Health costs on your employee's 2021 W-2 forms. Please consult with your CPA and, if necessary, read the document "<u>W-2 Reporting – Employer</u> <u>Provided Health</u>" in the BusinessWorks page on FLIsupport.com.
